Definitions and interpretation

1. In this privacy policy, the following definitions are used:

 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

- 3. This privacy policy applies only to the actions of Anopier Limited and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Anopier Limited is the "data controller". This means that Anopier Limited determines the purposes for which, and the manner in which, your Data is processed.

Data collected

- 5. We may collect the following Data, which includes personal Data, from you:

How we collect Data

- 6. We collect Data in the following ways:
 - a. data is given to us by you; and
 - **b.** data is collected automatically.

Data that is given to us by you

- 7. Anopier Limited will collect your Data in a number of ways, for example:
 - **a.** when you contact us through the Website, by telephone, post, e-mail or through any other means;
 - **b.** when you register with us and set up an account to receive our products/services;
 - c. when you complete surveys that we use for research purposes (although you are not obliged to respond to them);
 - **d.** when you enter a competition or promotion through a social media channel;

in each case, in accordance with this privacy policy.

Data that is collected automatically

8. To the extent that you access the Website, we will collect your Data automatically, for example:

This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

Our use of Data

Who we share Data with

- c. payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology.

Data retention

Your rights

- 20. You have the following rights in relation to your Data:
